<u>Covered Period</u>: July 1, 2012 through September 29, 2020 <u>Claims Deadline</u>: December 28, 2020 <u>Relief</u>: Backpay (premium pay) + Interest (10%)

#### **Claims Submission Process:**

- Claims will be reviewed in two-step process (locally, then nationally).
  - To file a claim, you must submit:
    - Claim Form (Attachment C) <u>AND</u> required documentation (leave approval).
- Claim Form and required documentation must be submitted to both:
  - Local Payroll Office <u>AND</u> VA Financial Services Center (email on Claim Form)
  - For assistance with Claim Form, contact your Local Payroll Office.

## **Frequently Asked Questions**

#### Question: Can my supervisor call or text my personal cell phone?

Answer: Your supervisor should *only* use your personal cell phone number to contact you about leave issues, schedule changes, or to ask you if you want to work overtime or comp time. If the supervisor is using your personal cell phone for other issues this is **against policy**. **Please contact the office and the union will contact HR on your behalf to have this stopped**.

# Leave Without Pay (LWOP) vs Absent Without Leave (AWOL):

As an employee you have the right to ask your supervisor to grant you leave without pay. However, your supervisor does not have to issue you leave without pay. If you are out of SL, and you call in sick and ask to use LWOP, it is up to the supervisor to decide if they will grant LWOP. Article 35- time and leave:

- 1. Requests for LWOP will be given serious, bona fide consideration.
- 2. LWOP may be requested in the same manner and for the same purposes as annual leave and sick leave. LWOP may be granted even though the employee has a sick or annual leave balance.
