## Where do I find the information in the AFGE/VA Master agreement?

## How do I find the master agreement? SharePoint, Google, M11-244

- Manager wants to remove a breakroom and make it a patient care area, is this union negotiable? Article 32 Section 2
- Manager wants the employee to call both the supervisor and time keeper when they call out sick, is this appropriate? Article 35 Section 4
- Employee wants to stop smoking, what benefit does the agency offer?
   Article 29 Section 19
- Employee has dropped below fully successful, what is the supervisor's responsibility? Article 27 Section 10
- Employee has received a parking ticket for a reason not related to illegal parking,
   should the employee have received a warning? Article 26 Section 4
- Employee found out there was a job opening and another coworker was given the promotion without allowing everyone to apply. Is this fair?
   Article 23 Section 8; Article 56 and article 61.
- A preferred tour of duty has opened in the department and a brand-new employee has been offered the position without consideration of their coworkers.
   Is this equitable? Article 21 section 3H
- An employee has been in trouble and the supervisor has decided to punish them
   by changing their tour. Is this appropriate? Article 13 Section 1D

- Employee is being <u>counseled</u> for behavior, (written counseling) and they ask for union, however the supervisor denies union representation. Is the denial of representation for a counseling allowed? <u>Article 17 Section 16</u>
- The director of the hospital has decided they will no longer meet with the union to discuss union related topics. What can be done? Article 4
- Supervisor <u>emails</u> the employee the decision to discipline. Is this right?
   Article 14 Section 9
- Employee comes into the office asking about a new fitness for duty that will test the employee for un job related requirements. Is this just? Article 19 Section 1
- An employee is offered a telework agreement, but only if they take a pay cut.
   Can they do that? Article 20 Section 7
- The unionist decides to record a meeting, but no one other than the steward knows about the recording. Is this allowed? Article 17 Section 4
- What are the 3 areas that should be discussed between union and agency when
  it comes to making major changes in the hospital. (look up the word Scope) "in a
  cooperative labor management relationship, the parties should discuss the
  following topics: Article 3 Section 5
- ADR or mediation is an informal process which seeks early resolution of \_\_\_\_\_\_,

- I was talking on my cell phone about a childcare issue and I was giving discipline.

- I am a title 38 hybrid and I asked for training that my coworker received and I was denied time for this training, what can I do? Article 37
- I am a title 38 hybrid and I meet the disability requirements to file for disability retirement, what are my options?
