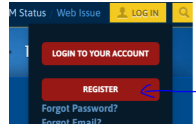

#### Calling all Registered Nurses

Our license will expire on 4/30/2023. Each nurse should go to the board of nursing for their state which can be found at [ncsbn.org/contactbon.htm](http://ncsbn.org/contactbon.htm) For the state of MO it is [Pr.mo.gov](http://Pr.mo.gov)

If you have difficulty once opening the website you might try using a non-mobile device, like a laptop or desktop computer. The cost is \$85 plus 1.95 transaction fee.

Submit your application by 4/27/2023 as it can take up to 72 hours to post to the NURSIS website. Once you have renewed send
